#### POWER & FUNCTIONS OF THE OFFICE BEARERS OF THE TRUST BOARD

The managing Trustees shall be the Chairman of the trust.

i) The Chairman shall preside over all the meetings ( under his supervision all the meetings of the Executive committee / General Body are to be conducted for ensuring the smooth conduct of its objectives.

ii) The Chairman shall convene any emergency meeting of the Trust Board in the event of any emergency.

iii) The Chairman will also act as the Chairman of the upcoming institution of the Trust. He is real executive head of the Trust and the upcoming institutions of the trust.

iv) The Chairman is to convene all the General Body meetings as well as all the executive committee meeting within 15 days notice for the Trustees.

v. All the activities of the Trust shall be carried in his name / seal and signature. He is ipso-facto the Chairman of all the committee / Bodies of the Trust and he is the overall head for the General administration of the Trust.

vi. He is to sign and execute all the connected documents of the Trust/ Upcoming institutions of the Trust. He is the person to sue or to be sued on behalf of the Trust/ Upcoming Institutions of the Trust.

vii. The Chairman shall carry out the day-to-day activities of the Trust / Upcoming Institutions of the Trust. In case of emergencies the Chairman, in consultation with the other trustees can take decisions.





ix. The Chairman is having all the power to appoint solicitor, lawyer, architect, engineers, and chartered accountants.

x. The chairman is vested with all the powers to interfere with the administration of the institutions established under the trust and his decision relating to all matters shall be final and binding and unaltered.

### 3. TRUST FUND

I. In order to effectuate the said object of creating or establishing the trust in the name and Style of **Shree Ganesh Trust** all the trustees above mentioned have given a sum of **Rs.5000 (five thousand)** each and they will after registration of the trust deed will give to the trust fund accordingly as to their rights and share as the trustees. The trustees may from time to time, for augmenting the Trust fund will receive donations and grants for the General purposes or the special purposes connected with the object of the Trust not calculated to impede the due working of the Trust and receive funds arising from subscription s , donations bequest from any other resources and objects aforesaid hereinafter called the Trust fund and also of the net income and capital of the Trust Fund for the purposes of the Trust and invest the surplus money available from year to year in the Bank deposits and other Government Securities as the Trustees deem fit.

II. The Chairman will regularly maintain the accounts of trust fund and the said amount will be audited by the competent auditor or chartered accountant each year.

In inviting reference to the subject cited above, I have inspected the Ganesh English Medium School, Baner building on dtd.24.12.2020 located at Plot No. 354/2958, 354/2959, 354/2960, 354/2824, 355/2825 over Khata No. 301/584, Mouza-Baner. The following observations were noted.

1. There are 16 nos of Class Rooms on ground, 1<sup>st</sup>, and 2<sup>nd</sup> floor alongwith separate principal chamber on GF, staff room on GF, Boys and Girls common room on Ground Floor, Library and Laboratory on First Floor.
2. For safe egress provision of stair case have been made. The Building is standing on 21,245 Sqft areas and the open area available is about 2.15 Acre (93645 sqft) which is 22% of the total Plot.
3. There is sufficient open space for play ground area inside the premises of school area.
4. Provision of proper ventilation for free air passage is there.
5. The ground floor / first floor slab / second floor are of RCC. The structure is RCC frame structure.
6. Details of the stair case, corridors, doors and height of class room are as per the approved plan and specification.
7. The premises is enclosed with barbed fencing and brick compound wall.


